I further agree to indemnify, defend and hold each of the Releasees free and harmless, with respect to all claims and liabilities asserted by any person, including any of the Releasees, for damages, losses, and/or injuries, arising out of or in any way connected with my or my Invitees' reservation and/or use of the Facilities including, but not limited to, any transportation to and from the Facilities, to the fullest extent permitted by law. I accept full responsibility and agree to promptly pay all costs to repair and/or replace any property of the Releasees damaged by me or any Invitee.

I understand and agree that, in the absence of this Waiver, the City of La Mirada would not provide the opportunity for me to reserve use of the Facilities, or offer the recreational activities or services described in the Party Reservation Form I signed.

I hereby give permission for videos/photographs of myself and/or my Invitees to be used in local newspapers, on television, in the City of La Mirada publicity material, or similar published materials for the sole purpose of promoting Splash/Buccaneer Bay.

I AM SIGNING THIS DOCUMENT WITH THE INTENT TO RELEASE AND HOLD HARMLESS IN ADVANCE THE CITY OF LA MIRADA, AND ITS ELECTED OFFICIALS, OFFICERS, EMPLOYEES, VOLUNTEERS AND AGENTS FROM ALL LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE AND/OR WRONGFUL DEATH, REGARDLESS OF THE ALLEGED BASIS OF LIABILITY, TO THE MAXIMUM EXTENT PERMITTED BY LAW. I HAVE READ THIS DOCUMENT AND FULLY UNDERSTAND AND ACKNOWLEDGE THAT BY SIGNING THE SAME I AM GIVING UP IMPORTANT LEGAL RIGHTS.
